





# Conversion Efficiency






### External components setting

FUSE: Fuse Please make sure to use quick acting fuse 1A

C1: Capacitor for input voltage smoothing

Capacitance: 22µF~820µF Rated voltage: 400V or higher Ripple current is 0.13Arms above.


